

# Choosing a School - Questions to Ask and What to Consider

### For Parents and Carers with a Draft or Final EHCP

Choosing the right school or setting is a big decision. If your child has an Education, Health and Care Plan (EHCP), you have the right to request a particular school, college, or other placement. This guide helps you understand your rights and gives you key questions to ask when visiting or considering a school.

# What Does the Law Say?

Under the **Children and Families Act 2014**, you have the right to request that the EHCP names a:

- Mainstream school or college
- Special school or college
- Academy, free school or maintained school
- Non-maintained special school
- Section 41-approved independent special school or college

The Local Authority **must** agree to your request unless:

- 1. The placement is unsuitable for your child's needs
- 2. It would affect the education of other pupils
- 3. It would not be an efficient use of public money

You do **not** have to visit multiple schools before making a request — but many parents find it helpful.

### **Before You Visit or Decide**

Ask to read:

- The school's **SEND Policy**
- Their Accessibility Plan
- Their Ofsted report
- Their Local Offer information

### You can also:

- Speak to the SENCO (Special Educational Needs Coordinator)
- Ask for a tour
- Talk to other families if you feel comfortable

### Questions to Ask When Visiting or Contacting a School

# About SEN Support:

- How does the school identify and support children with SEND?
- How is support personalised to meet individual EHCP needs?
- What experience do staff have in working with children like mine?

### About Staffing and Support:

- Who will be involved in supporting my child day to day?
- Will there be a key person or caseworker for my child?
- How do they work with external professionals (e.g. EPs, SALT, CAMHS)?

### **About Communication:**

- How often will I receive updates?
- How is progress monitored and shared?
- What's the process if I have concerns?

### About Inclusion and Wellbeing:

- How are children with SEND included in wider school life?
- How do staff support children with anxiety, school avoidance, or transitions?
- What support is in place for emotional wellbeing?

### **About Practicalities:**

- What is the school day like? What class sizes and groupings are used?
- How are breaks/lunchtimes structured for pupils with additional needs?
- What facilities or resources (e.g. sensory room, quiet spaces) are available?

# What Happens After You've Chosen a School?

- Let the **EHCP Case Officer** know your preferred school during your 15-day draft plan response window.
- The Local Authority will consult the school or college.
- The setting has 15 days to respond, and can only say no for specific legal reasons.

Once agreed, the school's name will appear in Section I of the final EHCP.

# **Things to Consider**

- Does the school have experience with your child's primary needs?
- Do they seem confident and welcoming?
- Will your child feel safe, understood, and included?
- Is specialist provision needed now or could this be reviewed later?
- Is travel or transport a factor?
